ADMISSION (FOR FLEMISH DEGREE STUDENTS)

- be in possession of the bachelor's degree 'Economische wetenschappen' / Economics
- via a **preparatory course**
 - preparatory course for **economic bachelors** (bachelors TEW, bachelors HIR, bachelors HW)
 - preparatory course for **other academic bachelors**
- via a **linking course**
 - only for '**professional**' bachelors
- via an **individual programme (GIT)**
 - combination of courses from bachelor and master Economics
 - combination of courses from preparatory course and master Economics
 - combination of courses from linking course and master Economics

STUDY PROGRAMME MASTER ECONOMICS

- one-year programme taught in English
- the master Economics has 2 majors
 - a major is a group of adjacent (elective) courses
 - you can specialize to a limited extent through a major
 - at least three courses must be chosen from one major
- there are 3 general courses

WHAT IS A DOUBLE DEGREE?

- Two degrees:
 - Ghent University degree
 - Degree of another university
- Duration: 2 years
 - 1 year at Ghent
 - 1 year at the partner university
- Students pay the regular tuition fee at UGent
- Students can apply for a scholarship
- 5 places available
