

TUITION FEES FOR NON-EEA STUDENTS 2026-27

The tuition fee for non-EEA students (for enrollment in one of our Master Programs or English Preparatory Programs) is **tariff B**:

Standard tuition fee (€ 305.40 fixed amount + € 31 per credit) + higher tuition fee (€ 81.90 per credit)

For 60 credits: € 7079.40

The following **exceptions** apply:

- Students who **were already enrolled in the AY 2024-25** and re-enrolled in the AY 2025-26 will continue paying the tuition fee by tariff A in the AY 2026-2027:

Standard tuition fee (€ 305.40 fixed amount + € 17.70 per credit) + higher tuition fee (€ 15.50 per credit)

For 60 credits: € 2297.40

- Students from the **following categories** pay the same tuition fees as EEA students:

€ 305.40 fixed amount + € 14.60 per credit.

For 60 credits: € 1181.40

Or € 139.40 (flat fee) for students with a study allowance Flemish Community ("Studietoelage Vlaamse overheid")

1. [Electronic Residence Card](#) (mentioned in [Art. II.215 Codex Higher Education](#))
2. Applicants for international protection (persons with a legal residence but who's application for international protection is still pending with the government) pay the tuition fee as for EEA-students with no study allowance from the Flemish government. Certificate of Immatriculation (orange card) + annex 26 is needed (valid at enrolment or before 31/12 of the AY).
3. Non-EEA students with a temporary status of protection (rule is valid until the 4th of March 2026). A-card is needed (valid at enrolment or before 31/12 of the AY).
4. Non-EEA students who are a first degree relative of a national of a member state of the European Economic Area (valid at enrolment or before 31/12 of the AY).
5. [VLIR-UOS scholarship holders](#) - UGent document needed upon enrolment
6. Student from [OESO/DAC recognised developing country \(lowest 2 categories\)](#)

- Students **with the nationality from the following countries** pay tariff B with a 100% waiver:

Standard tuition fee (€ 305.40 fixed amount + € 31 per credit) + € 0 higher tuition fee per credit (waiver). For 60 credits: € 2165.40
