### PhD researcher – Ghent University

As a doctoral researcher at the Law & Diversity and the Migration Law Research Groups at Ghent University (Belgium), I examine how EU externalisation migration policies construct masculinity. This PhD project is supported by the Flemish Research Fund (FWO).

### Protection Officer – Office of the Commissioner General for Refugees and Stateless Persons (current position)

As a Protection Officer, I conduct extensive interviews with applicants for international protection regarding all aspects of their case, actively listening to their stories and circumstances. With a thorough understanding of the countries of origin, I assess the credibility of the applications. Based on immigration law, I determine whether the stated reasons meet the criteria for a protection status. Additionally, I carefully motivate decisions regarding the granting or denial of refugee status or subsidiary protection.

### Gender Advisor – Office of the Commissioner General for Refugees and Stateless Persons (October 2023 – May 2024)

As a member of the CGRS-gender unit, I contributed to the development of gender policy. This involved analysing relevant legal doctrine and case law, drafting policy proposals, providing training, and communicating with relevant stakeholders in the field.

### Council of State – Youth Parliament

As a Corporate Tax Advisor, I had the opportunity to work in a team on various projects for large multinationals. My responsibilities mainly included advising clients on new tax legislation, analysing the potential tax implications of a client's businessplan, assisting clients during a tax audit by the tax authorities, and negotiating tax rulings.

### Volunteer Legal Advisor – Legal Advice Centre for Rental Issues

I advised low-income individuals in rental disputes and mediated between tenant and landlord to find a mutually agreeable solution.

Within ELSA, I was responsible for organizing the annual moot court competition, coordinating various practice-oriented workshops and international study trips, with a highlight being the visit to the United Nations in New York.
